Eden Murrie is the Chief Operating Officer for Operation Stand Down Tennessee (OSDTN), a veterans' resource non-profit. Prior to assuming this position, Eden was a Director at the Partnership for Public Service, a Washington DC non-profit.

She served as Commander, 100th Air Refueling Wing, Royal Air Force Mildenhall from June 2007—September 2009; and culminated a 29-year Air Force career as the Director of Air Force Services in Washington DC. She has senior executive experience including working on the National Security Staff for the White House, serving on the staff of a Member of Congress, developing and executing a \$2 billion portfolio of worldwide programs and leading multinational organizations. Additionally, a master navigator with over 2400 flying hours, her flying career included serving as an instructor in 3 different aircraft (KC-135A/R, the CT-43A and the EC-135N.)

Beyond business endeavors, Eden is a board member for The Women in Military Service for America Memorial Foundation, Tennessee State Veterans' Homes, Centerstone Military Services and the Davidson County Veterans Court Foundation. Additionally, she is an adviser for the Nashville YWCA Dress for Success program.

Eden is a graduate of the United States Air Force Academy and has MA's in Political Science and National Security Strategy and an MBA from Vanderbilt's Owen School of Management.

Legislative Update

STATE: BILLS OF INTEREST:

- **SB 0673/HB 0787** -As introduced, requires TVS (Veteran's Services) to provide training in mental health crisis management to the employees of the department who directly interact with veterans for the purposes of assisting veterans with mental health issues.
- Status-Passed House, Passed Senate-Amended to authorize DVS to utilize resources from Veterans groups to provide training.
- HJR 0831/HJR0835-Both are Resolutions to recognize women veterans by a resolution. HJR 0835 establishes the date as June 12. Status-Both referred to Senate State and Local Government
- **HB1146/SB0852**-As introduced, increases the number of free plates from one to two for the Purple Heart and disabled veteran license plates issued to veterans with disabilities.
- Status-House-Returned to Clerks Desk. Senate—Deferred in Finance Ways and Means
- HB2195/SB2557-As introduced, enacts the "Major Trevor Joseph Act," which requires the department to provide burial services for any person who died while on active duty with the armed forces and is being interred in a state veterans cemetery on any date requested by the family members of the person if the department is given notice of the burial at least 72 hours in advance of the burial.
- Status-House—Assigned to sub-committee Departments and Agencies. Senate-Referred to State and Local Government.

FEDERAL: ITEMS OF INTEREST:

- The Army requested \$178 billion in its fiscal year 2021 budget request, which represents a decrease from last year as the branch says it will focus on quickly adding capabilities and funding its staff. Estimates include a 300-member increase in the Army Reserves and a 500-member increase in the Army National Guard.
- The **Defense Department** submitted a \$705.4 billion budget proposal to Congress today, seeking increased funding for nuclear weapons systems, technology research and the Space Force. The proposal is for the next fiscal year, which starts Oct. 1.
- Sen. Gary Peters, D-Mich., has introduced a bill that would create a three-digit hotline for veterans to help them learn about their benefits and link them with other services. "We must ensure veterans in Michigan and across the country can easily access the VA benefits they have earned," he said.
- The Wall Street Journal reported that the Army's new corps headquarters, the Fifth Corps, will be based at Fort Knox and will rotate Soldiers to a command post in Europe. Defense One reported that 100 Soldiers will be transferred to the Space Force in 2021
