# **MOAA Guidance on 2020 Elections**

As organizations exempt from federal taxation under Sec. 501(c)(19) of the Internal Revenue Code, MOAA and its affiliate Chapters must take care to avoid engaging in partisan political activities. Under IRS rules, we are prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for public office.

As individuals, members and leaders of MOAA and MOAA Chapters are not prohibited from engaging in partisan political activities so long as it is done in way that makes it clear they are acting for themselves and do not appear to be speaking on behalf of MOAA. For example, it is permissible for an individual to express his or her personal preference in support of or in opposition to a candidate or political party. And they may do so publicly. However, when expressing their personal opinions or preferences, they may not make reference to their MOAA position, use MOAA communications channels, use MOAA letterhead or newsletters, identify themselves as MOAA leaders, or imply that MOAA or its members share their beliefs.

By now you should have received our request for contributions to the MTC MOAA Veterans Scholarship program. To date, we have funded three endowed MOAA national scholarships for \$25,000 each and are contributing to a fourth. Three years ago, because of our strong relationship with Lipscomb, we inherited a dormant endowment scholarship and started funding it under the Middle Tennessee MOAA moniker. This endowment fund is in addition to the annual grant that we provide.

Our tradition is to ask every member to make a minimum \$25.00 tax-deductible contribution to support this initiative. Historically we have had some members want to contribute directly to MOAA national. If you do so, please annotate your check for your donation to be credited to the Middle Tennessee Chapter. A self-addressed envelope was included with the mailing, or you can drop off your check at the front desk at our next meeting. Many of you already mailed in your contributions so we are off to a nice start on this scholarship drive. If you have not yet contributed, I ask you to consider doing so. A special thanks to all who already contributed and thank you in advance for those who will also support this worthy program.

If you have not read your September Military Officer magazine, Phil Ponder from Nashville is highlighted on page 104 and separately, there is a truly relevant article on page 18 talking about duty status (pay) reform for reservists. Those who have served in the reserves will recognize the issues that exist and how this is moving its way into legislation.

# **Legislative Update**

### **STATE**

In March, Governor Bill Lee authorized the activation of the Tennessee National Guard to assist with the fight against COVID-19. Since then, the Guard has been teaming up with the Department of Health and various other state and local agencies to combat COVID-19 in communities throughout the state. Establishing Remote Assessment Sites to test citizens and determine if they have been infected with COVID-19, over 1,900,000 tests have been administered at these locations, and the Tennessee National Guard is responsible for more than 280,000 of them.

"At Meharry we have a mission that says we serve our community through God," said Gray. "The guardsmen definitely align themselves with that train of thought as well. They are very willing to help their neighbors in this fight against COVID-19." Initially, Gov. Lee requested 250 Soldiers and Airmen from the Tennessee National Guard to provide support in response to the pandemic. Since then, over 2,000 guardsmen have been activated in some capacity to serve their communities and many are still activated today.

Going forward, Meharry Medical College and the Tennessee National Guard will continue to test members of the community for the virus, helping limit the spread so we can conquer this enemy and get back to a sense of normalcy.

# FEDERAL

Stars and Stripes reported that the 41st Field Artillery Brigade activated its second Multiple Launch Rocket System unit in Germany, providing additional long-range fires capabilities for U.S. Army Europe and EUCOM.

Military Times reported that 5,400 Louisiana National Guard members and more than 1,000 Texas National Guard members were activated for Hurricane Laura relief efforts.

A U.S. Navy destroyer passed near contested islands in the South China Sea again Thursday, the same day Defense Secretary Mark Esper emphasized the Pentagon's intent to continue challenging Beijing's territorial claims in the region.

Leaders from U.S. and Russian militaries are stepping up their war of words over a collision involving armored vehicles in Syria on Tuesday that injured seven U.S. service members. Following its "unauthorized incursion" into the area, the Russian convoy met a joint patrol of U.S. and Syrian Democratic Forces troops and proceeded to "aggressively and recklessly pursue" the coalition convoy, Urban said. The encounter included a "sideswipe" of a U.S. vehicle and an "extremely low level overflight" by a Russian helicopter.
