As we begin a new year, I sincerely hope chapter members enjoyed a restful break and cherished time with family. The past year brought wonderful progress for the chapter in terms of advocacy, community outreach and camaraderie. We will build upon this positive momentum in 2023 while continuing to provide steadfast support to the resolutions of MOAA National.

Our chapter luncheon on Tuesday, 24 January 2023, will be devoted to reviewing annual achievements in numerous areas ranging from finances to scholarships to community outreach, among others. There is great news to report!

The start of the year also brings renewed attention to state and national advocacy actions. Substantial gains for active-duty troops, veterans, military dependents and surviving spouses were made because of persistent advocacy during the 112th Tennessee General Assembly and 118th United States Congress. Now, it is time to shift focus to new legislation being introduced at the state and national level. The first major advocacy effort begins on Wednesday, February 1, 2023, when the TN Veterans' Day on the Hill is held. Veterans' organizations from across the state will travel to Nashville to meet with their legislators on a designated set of topics. All are welcome to participate, the registration link is on the calendar on page 2.

In December 2022, chapter members should have received e-mails regarding the update of the chapter bylaws. Two past presidents devoted considerable time to reviewing our current bylaws. Proposals involve updating them to reflect new procedures like electronic voting and compliance with MOAA's council and chapters policies and procedures guide. Additionally, appendices were added to provide guidance for key director duties. If you have not received the bylaws review e-mails, please contact chapter leadership as soon as possible. In-person voting on the bylaws and new appendices will occur at this month's luncheon.

Finally, this will be my final year as chapter president in accordance with the two-year term limit. It is imperative that a volunteer step forward to fill the first vice president vacancy, so an orientation period can begin. With all the awesome talent in the chapter, I know the right person is out there!

Legislative Update

Happy New Year to all of us in the Middle Tennessee Chapter. We begin another year of good fellowship and support of our uniformed services in their many aspects of our national life.

January 3rd at Noon Eastern Time is the turnover time for our Representatives and Senators. Things in Washington are unsettled as I write, but they will get resolved so that Congress can get working on its many responsibilities. Across the Potomac River in Alexandria, our MOAA Legislative Advocacy people continue their work of serving our membership and families in real time. The January issue of Military Officer magazine always articulates the Mission Advocacy priorities for the year, and please do take time to read it. Reading it will alert your attention to ideas and initiatives that we discuss in the whole of 2023.

In late April 2023, MOAA National will host Advocacy in Action as an inperson event in Washington DC.

Here is an important quote about how we cooperate to align with "strategic enablers" that serve veteran health needs. The source is the new VA Undersecretary for Health, Dr. Shereef Elnahal. "Partnering with VSOs (Veteran Service Organizations), states, and advocates, and interagency cooperation.", page 15. All such groups have priorities that differ and yet align toward the larger picture of the meeting needs of the greater uniformed services community. The PACT Act recently passed and all manner of legislative support for the VHA reaches us individually as we need them, and they support all who look to organizations like MOAA for leadership. Watch for news on these items all year long in this column.

Our chapter is closely aligned with Operation Stand Down Tennessee. OSD TN is opening a third location on January 9th in Columbia to deliver more services in Middle Tennessee. Their Grand Opening will be January 18. Our close relationship with OSD TN is a shining example of how we continue to serve long after hanging up our uniforms.

Finally, on page 41of the MOAA magazine there is a wonderful article about our Chapter President, LtCol Karon Uzzell-Baggett, USAF (Retired). Take care to read it twice. It shows how we never stop serving and how after our uniformed service finishes, we then find new ways to serve. Additionally, pages 64-65 of the same edition feature an outstanding article on the Surviving Spouse Liaison for our chapter and the council, Mrs. Patricia Bergquist.
