Lieutenant General Jason T. Evans, USA Retired has over 30 years of serving in and leading the Army's most prominent complex Human Resources commands and organizations.

As an accomplished strategic leader, he has extensive command and staff experience at every level of the Army. His postings include Italy, Somalia, Kosovo, Germany and Iraq. The General had various command assignments with the 13th Corps Support Command, III U.S. Corps to include the 510th Personnel Services Battalion, 1st Personnel Command U.S. Army Europe, Allied Forces Southern Europe, Headquarters Installation Management Command, Multi-National Forces -Iraq, Army Human Resources Command, Army G-1, and Office of the Assistant Secretary of the Army. His career culminated in serving as the Army's first Deputy Chief of Staff, G9 (Installations). In this role, he oversaw budget management of a \$18 billion portfolio and policy development, and he led key initiatives to improve the quality of life for 1.1 million soldiers and their families. He possesses over 30 years of human resources experience, including policy development, talent management and overseeing Army-wide HR strategies.

He holds an AA degree in Business Administration from Wentworth Military Academy, bachelor's degree in business administration from Bellevue University, NE and master's degrees in business administration and national resource strategy from Webster University, AR and the Industrial College of the Armed Forces, Washington, DC

Legislative Update

Information reaching us from MOAA Headquarters is that 100 members of the 119th Congress have served in our armed forces. That may not seem like a lot, but it is an increase over the 118th Congress. There is good reason for optimism with that increase, because it tells two things: one is that the culture is changing to bring military and naval leaders to offer themselves for legislative service and the second is that the voters are valuing that kind of leadership.

This is a dramatic shift from the October article in Military Officer about how the rate of military service in Congress had dropped over decades from about 80% to 18% -- with the result being that those making critical decisions about personnel matters and arms purchasing lack the experience and expertise to make those things happen and happen well.

Not coincidentally, recent recruiting numbers are way up. Will ROTC and JROTC participation rise, too?

And so I wonder whether that kind of change will happen in our Tennessee Legislature in the next election. I don't have numbers, but change is always happening. Life happens at the speed of change.

For those of us attending the Tennessee Veterans (TNVET) "Veterans Day on the Hill" in late January, changes have come to the list of four issues for which TNVET is lobbying. The list of the four issues came with last month's column. There is a joint bill JHR001 which memorializes Congress to begin action to bring Hyperbaric Oxygen Therapy availability to the veteran's community. This process effectively treats traumatic brain injury and PTSD patients. We learned that there is an under-availability of this in the medical community for civilians as well as veterans and that is a very expensive process. We also learned that there will not be state initiatives until there are already federal actions, so this will take years to accomplish; thus, the Legislature is memorializing Congress to begin. Expect this matter to last for years.

And as if by coincidence: the evening before Vets Day there was a contestant on *Jeopardy Tournament of Champions* who had recovered from traumatic brain injury through Hyperbaric Oxygen Therapy and testified to its effectiveness.
