Council President Ivan Adames began the meeting at 11:30 am.

Council Vice President Pete Warner led the pledge to the flag. Following the pledge allegiance to the flag. Chaplain Eddie Sumbler had technical difficulties; Monroe Gildersleeve said a short prayer of opening for the meeting.

Acceptance of Minutes

An amended minutes of the 19 October 2022 meeting had been sent out on 14 January 2023 to all the chapter presidents and Council members. Steve Petersen moved that the minutes be accepted as amended. The motion was seconded by Monroe Gildersleeve and approved unanimously.

Financial Report

Monroe Gildersleeve, Treasurer, delivered the financial report for the period of October 01, 2022 to December 31, 2022. The Council had two receipts during the quarter, TNVET Annual Membership Dues of \$100 and reimbursement for Zoom of \$114.18. Total funds on hand at the end of the quarter were \$6,339.30, which included restricted travel funds of \$1,150.0.

The Council made its' contribution to TNVET for annual membership dues of \$100 when the notices were sent out. TNVET membership dues are based on the numbers of members in the composite Chapters has.

The Council accepted the Treasurer's Report.

Surviving Spouse Report

Chapter Presidents of the following chapters: *East TN, General Andrew Jackson, and Upper Cumberland* need to update their Chapter Surviving Spouse Liaison information (name, phone, and e-mail address) with Patricia regardless of whether a change has or has not occurred. SBP OFFSET

The third and final phase of the Survivor Benefit Plan/Dependency Indemnity Compensation (SBP/DIC) Offset Repeal for those impacted will be reflected in February 2023 annuitant pay. The Survivor Benefit Plan (SBP) benefit will be paid in full; Dependency Indemnity Compensation (DIC) will be paid in full, and Supplemental Survivors Indemnity Allowance (SSIA) will permanently stop.

Also, surviving spouses who turned their Survivor Benefit Plan benefit over to their child/children who were not offset will see the benefit restored to the surviving spouse. *If affected, please check with DFAS regarding any necessary paperwork for the reversion.*

Note of caution: If you are given the option to opt out of SBP based on 100% disability from VA, do not forget that the rules have changed as survivors can now receive the full amount of both benefits.

NDA 2023 Survivor Benefit Plan (SBP) Open Season began on December 23, 2022 and ends on January 1, 2024. The SBP Open Season

Allows retirees receiving retired pay, eligible members, or former members awaiting retired pay who are NOT currently enrolled in SBP or RCSBP (Reserve Component Survivor Benefit Program) to enroll.

ADVOCACY/LEGISLATION

The SBP/DIC Offset Repeal took years to accomplish! It required the focus and diligent work of MOAA Chapters' surviving spouses along with surviving spouses through FaceBook who did not qualify for MOAA membership to personally contact their Congressmen and Senators on the issue.

We need that same focus and diligence as we continue to advocate for more legislative changes for our surviving spouses as follows:

H.R.2214 and S.1669 - "Military Retiree Survivor Comfort Act" would allow for retention of the full final month's retired pay by the surviving spouse or other designated survivor, of a military retiree for the month in which the member was alive for at least 24 hours.

The legislation would allow for repayment over a 12-month period and gives the Secretary of Defense the option to forgive the payment. *This bill is important for all "future" military surviving spouses.*

H.R.2214 has 44 co-sponsors (2 from TN: Cohen and DesJarlais)

S.1669 has 7 co-sponsors with NONE from TN

H.R.3402 and S.976 – “Caring for Survivors Act of 2021” are to improve and expand eligibility for the DIC Increase from 43% of a single, 100% disabled veteran’s compensation to 55%. The 2023 DIC flat rate is \$1,564.74 per month.

H.R.3402 has 73 co-sponsors (2 from TN: Steve Cohen and Jim Cooper)

S.976 has 14 with co-sponsors NONE from TN

H.R.2827 CAPT James C. Edge Gold Star Spouse Equity Act “Remarriage Bill 2021” and S.4841 “Love Lives on Act 2022”

Surviving military spouses are not allowed to remarry before the arbitrary age of 55 without losing ALL their benefits. Only 7.4% (30,045) of surviving spouse DIC recipients are under the age of 56. The Gold Star Equity Act seeks to correct this injustice by preventing the termination of benefits to a surviving spouse due to remarriage.

H.R.2827 has 25 co-sponsors with NONE from TN.

S.4841 has 1 co-sponsor with NONE from TN.

H.R. 6849 - “Supporting All Veterans Families Act” has 4 co-sponsors with NONE from TN. This act would update certain terminology related to marriage under Title 38, US Code Section 101(3) and Section 5120(b) administered by the VA. It is understood that the language has not been updated since inception, and the archaic terminology should be removed. No other federal survivor program or beneficiary has inference of marriage.

Once the 118th Congress is settled, we will have new bill numbers. I will advise when we have those. Until then, please contact your Congressmen and Senators for co-sponsorship of these pieces of legislation impacting our military surviving spouses across Tennessee. It is easier to get them to co-sponsor a new bill if they have co-sponsored the original bill.

The PACT Act included several pieces of legislation including the Camp Lejeune Justice Act (Period: between August 1, 1953 and December 31, 1987). As the article in the “Military Officers of America magazine” (October 2022) states: **“Veterans are not the only ones affected by the law: Anyone “who resided, worked, or was otherwise exposed (including in utero exposure) for not less than 30 days” during the above time period may bring action... to obtain appropriate relief for harm that was caused by exposure to water at Camp Lejeune.”**

Chapter Updates

Chattanooga TN01 - Carol Grohn written comments as follows:

Membership: 163 and 1 new member coming in February.

October: MOAA TN Chapters and Councils meeting was attended by 3 of our members: Ray Adkins, Carol Grohn, Billy Hewitt.

On October 25, 2022, our Nominating Chair presented the slate of Officers and Directors for 2023-24. At this point there have been some changes necessitated and re-affirmation of the slate will occur prior to the planned installation Feb 28th, 2023.

Speakers for October dinner meeting included the Hamilton County **Veteran Service Officer**, Chuck Alsobrook, who rather emergently discussed the up and coming (at that time) Pact Act. Little did we know that one of our own new members MAJ Andy Bailey was ill from toxic fumes in Afghanistan when he hovered over them in his helicopter and he had just been diagnosed with esophageal cancer; and despite all efforts at both Vanderbilt and in Houston, he died sadly as a newlywed 3 just months later. The **second planned speaker in October** was Brad Cobb and Sergeant Clay Tolson (Chattanooga policeman) who provided the stories and slides of their humanitarian relief effort trip to Ukraine.

Our bi-monthly Newsletters consistently have a sizeable chunk of **Legislative Affairs** information, including instructions on how to learn about Advocacy in Action.

Every month, our **Surviving Spouses and Spouses** luncheon group meets purely for social time together at the Mountain City Club. We are in the process of inviting *Patricia Bergquist* for a joint regular dinner meeting with the spouse lunch bunch to hear all the amazing legislative information that pertains to them, hopefully in mid-2023.

November - Veterans Day Parade – 5 members participated in the annual (Fort Oglethorpe, GA) Honor Park Committee **Veterans Day Parade**

9 November 2022 – **Member CPT Larry Taylor** was featured on local Times Free Press front page as part of their salute to veterans. The article recounted his heroic helicopter rescue in Vietnam in 1968, for which he was awarded the Silver Star but he is also *being considered for a Medal of Honor*.

December

Speaker for the bi-monthly December dinner meeting was **BG Scott E. Brower, USA (Ret)**, a West Point graduate and now Director of Vanderbilt University's Bass Military Scholars Program; he discussed his many roles which included assignments with both the 3rd and 5th Special Forces Group; his combat experience also included invasions of Afghanistan and Iraq, and Pakistan. He served with and helped train the 12 Horsemen for entry into Afghanistan for Operation Enduring Freedom.

Christmas Gala entertainment included our beloved Chattanooga Choo Choo Barbershop Chorus who entertained us for 20 minutes. Some of them are veterans, too.

Wreaths Across Chattanooga (WAC) Donation of money and time for the Chattanooga National Cemetery:

2022 - \$2000

2023 - \$1000 – + over \$500 in personal donations given to be doubled under the WAC program so the WAC donation for 2023 will be over \$2000.

Scholarship Fund: Contributions have been down after two years of pandemic plus inflation factors have impacted our brokerage account total and we are promoting more donations to continue awarding scholarships totaling \$4000/yr to JROTC and ROTC Cadets. Last year we received no applications so in 2023 the new scholarship committee will be heavily seeking takers for the COL Wm L. Ray Memorial Scholarship which is for JROTC cadets who commit to enrollment in a Senior ROTC Program at university level with a proven track record. The ADM Bobby Crates USN Scholarship Fund is awarded annually to a UTC Senior ROTC Cadet who best exemplifies the tenants of exceptional performance and leadership.

Applications are due by 24 March, 2023

PREPARATIONS FOR THE INCOMING 2023-2024 BOD: The incoming board of directors have been working ahead so they can be ready to roll after installation on Feb 28th. They have been developing a new concept organizational chart complete with job descriptions. This concept gives specific sets of responsibilities to the directors as well as the additional committee chairs. We have also been exploring ways to fundraise with a specific volunteer couple who have experience in setting up golf tournaments and have relationships with a golf club manager where they live. We have found a woman in the Spouses' Group with grant writing experience. We are exploring the issue we have with homeless veterans who die on the streets and have no family to claim them. We have been in touch with the legal secretary of our county who is very interested in this project. Also, the funeral home and veteran volunteers which end up consistently having to absorb the cost of dealing with passed veterans' final end-of-life expenses are very happy that we are exploring ways to take care of our own. We hope to develop the following committees: Finance, Membership, Social Planning, Awards and Recognition, Nominating, Interagency Coordination, Technical Services, Scholarships/Grants Trustees, Bereavement, and Fundraising. We have sought legal advice about how this jives with our current by-laws and apparently there is no problem. We are in the process of developing a new website, QR code, connection with social media, etc. We are preparing for installation with a fine new program with speaker Criminal Court Judge Boyd Patterson who has been working closely with COL Chris Dooley and others to establish Hamilton County's first mental health court and more. Further, we are developing plans to have a social event every other month offset with our traditional dinner meeting. This is in response to younger members who want more "downtime" with families as a group. Our new board/committees consist of several people new to MOAA or people who have not served on our board before!

East Tennessee TN02 (Knoxville) - Written update not provided

Memphis donated about \$1200 toward the VA holiday food basket program that provided a month's worth of food to 300 veterans the week before Christmas.

For speakers, we enjoyed Mrs. Billie Cash in October. She is an award-author, wife of retired Navy Captain Roy Cash, mother to currently servicing Navy chaplain Rear Admiral Carey Cash, and mother to former Miss America Kelley Cash.

In November our President provided a briefing on the Annual Meeting that was held in October.

In December we held our annual Surviving Spouses' Luncheon with Patricia Bergquist as our guest speaker along with our Council of Chapters President, Ivan Adames.

Middle Tennessee TN04 - Karon Uzzell - Baggett: written comments as follows:

Middle Tennessee MOAA First Quarter 2023 Update I. Luncheon Meetings a. January 2023 – Chapter members gathered for a review of 2022 accomplishments and reports from various directors. The meeting drew 41 attendees, which is large for this topic. The Chapter's financial status was reviewed and upcoming National and State legislative issues were highlighted. Members approved revised Chapter bylaws and eight new appendices outlining director duties. b. February 2023 – The chapter gathered to hear a presentation on the Battle of Nashville and the contributions of the United States Colored Troops in recognition of African American History Month. There were 47 attendees at Old Natchez Trace Country Club. c. March 2023 – Chapter members learned about The Mission Continues, a non-profit focusing on veterans engaged in community-based volunteer projects. The meeting was led by a past Chapter President due to the current President being at a conference. II. Advocacy a. Members received reminders about advocating for various legislation benefiting the military community at every meeting. The MOAA Legislative Action Center was frequently mentioned. b. The Legislative Liaison highlighted important issues pending before the 118th Congress. He stressed encouraging legislators to resubmit the Major Richard Star Act, support restoration of BAH to 100% and reverse cuts to TRICARE pharmacies. III. Community Outreach a. Members completed the final 2022 MOAA Community Outreach Grant on Saturday, March 4, 2023, at Matthew 25, a local non-profit focusing on rehabilitating formerly homeless veterans. The non-profit received two new computers and printers for the men to use in job pursuits. Chapter members delivered an in-person presentation to 22 men on resume development, interview techniques and other job placement topics. b. Three new grant requests for 2023 were researched and submitted to MOAA. IV. Award – The chapter submitted its second website nomination for the Colonel Marvin J. Harris Communications Award. V. Other a. The chapter submitted a \$300 request under the MOAA Community Outreach Sponsorship program to purchase a tablecloth and flag emblazoned with the chapter's name. These items will be used during chapter recruiting events. b. A community trip to the Tennessee State Museum was scheduled on March 23, 2023, as a follow-up to the February 2023 speaker presentation. Members enjoyed a complete tour of key museum exhibits. c. Key leadership vacancies still exist, but dedicated volunteers keep the chapter going forward.
