Council President Ivan Adames began the meeting at 11:30 am.

Council Vice President Pete Warner led the pledge to the flag. Following the pledge allegiance to the flag. Chaplain Eddie Sumbler said a prayer of opening for the meeting.

Acceptance of Minutes

An amended minutes of the 19 January 2023 meeting had been sent out on 14 January 2023 to all the chapter presidents and Council members. Betty Moshea moved that the minutes be accepted as amended. The motion was seconded by Pete Warner and approved unanimously.

Financial Report

Monroe Gildersleeve, Treasurer, delivered the financial report for the period of January 01, 2023 to March 31, 2023. Total funds on hand at the end of the quarter were \$6,339.30.

The Council accepted the Treasurer's Report.

Surviving Spouse Report written update provided by Patricia Bergquist as follows:

Chapter Presidents of all Tennessee MOAA Chapters have provided their Surviving Spouse Liaison information except *East TN, General Andrew Jackson, and Upper Cumberland.* Those Chapter Presidents need to send their Chapter Surviving Spouse Liaison information (name, phone, and e-mail address) to Patricia by e-mail at p_bergq@hotmail.com so that contact information can be updated.

When Chapter Surviving Spouse Liaisons need assistance helping a surviving spouse, please call Patricia (615-948-4960) or e-mail her for advice. The Surviving Spouse Representative on the MOAA National Board of Directors should not be called as she gives the surviving spouse Patricia's name and calls Patricia herself to tell her what advice, if any, she offered which often is not the best path. Our Surviving Spouses deserve accurate information, compassion, understanding, and hand-holding through the process.

ADVOCACY/LEGISLATION

We need the focus and diligence of all MOAA Chapter members and surviving spouses to personally contact their Congressmen and Senators on these issues as we advocate for more legislative changes for our surviving spouses as follows:

<u>H.R.1083</u> and <u>S.414</u> "Caring for Survivors Act of 2023" are to improve and expand eligibility for the DIC Increase from 43% of a single, 100% disabled veteran's compensation to 55%. The 2023 DIC flat rate is \$1,564.74 per month.

H.R.1803 has <u>18 co-sponsors</u> NONE from TN S.414 has <u>2 co-sponsors</u> NONE from TN

Everyone needs to be aware that the bill has a "special rule" section that penalizes 16,572 (3% of all DIC spouses) pre-1993 rank-based DIC recipients.

The understanding is that if a rank-based DIC recipient is receiving more than the flat rate, there would be no increase, and if he/she is receiving less than the flat rate, then he/she would be brought to flat rate.

Rank-based surviving spouses who would be impacted if the bill becomes law need to call or e-mail Congresswoman Johanna Hayes (202-225-4476), and Senator Jon Tester (202-224-2644) to express concern over this limiting language in the bill.

H.R. 854 CAPT James C. Edge Gold Star Spouse Equity Act

Surviving military spouses are not allowed to remarry before the arbitrary age of 55 without losing ALL their benefits. Only 7.4% (30,045) of surviving spouse DIC recipients are under the age of 56. The Gold Star Equity Act seeks to correct this injustice by preventing the termination of benefits to a surviving spouse due to remarriage. *No Senate Bill yet*.

H.R. 854 has 5 co-sponsors with NONE from TN.

"Military Retiree Survivor Comfort Act" and "Supporting All Veterans Families Act" do not have 2023-2024 Bill numbers yet. *The Bills will be reintroduced in the House and Senate and Bill numbers will be provided when available.*

The PACT Act included 22 additional presumptive causes of death from toxins.

Surviving spouses who were previously denied VA Dependency and Indemnity Compensation should contact a Veteran Service Office to see if they can file a claim under the PACT Act. The VA has said they will contact those surviving spouses, but surviving spouses do not need to wait for their contact. Be proactive!

Chapter Updates

Chattanooga TN01 - Carol Grohn written comments as follows:

Dual Member/Surviving Spouse: Our chapter experienced an unexpected death in December of one of our members who was just 40 years old. His death was consistent with many covered under the PACT Act. The couple had been married only a few months and he had young children. I have remained in contact with the surviving spouse and now new member. If desired by the surviving spouse, our chapter's by-laws allow the surviving spouse to continue the membership of the deceased member for a year following the death. The deceased also had a basic membership with National MOAA. In January, I got the spouse in touch with National who counseled her on her options to continue his basic membership or increase the level. She is in the process of making that decision as she continues with managing the estate and now "mentoring" the children. She will come to dinner meetings and has accepted an offer to be a volunteer on a major project that our chapter is embarking on. I hope that she will work with our current surviving spouse liaison to change the direction of our current group away from a purely social group that is a mix of long-term regular spouses and surviving spouses.

Brainstorms: In January various members of the incoming board gathered several times to brainstorm about our structure, types of dinner speakers for the year, and, importantly, social events for the year. We discussed fundraising options, how we wanted to give ourselves a new look and feel and broaden the appeal to attract new and younger members. It so far seems to be working out well. We have a new "living document" organizational chart that has a business look to it even with dotted lines of communication, committees, etc. This chart also has job descriptions. Our social planning lead is the wife of our Webmaster.

Installation: February 28th: Installation of our new board occurred per a popular new local judge. For the first time, our chapter has had its first female president.

Grant: We have applied for our first grant to provide for final rites and processing for homeless indigent veterans unclaimed by families.

Golf tournament: To raise funds for our JROTC SROTC scholarship grants, we are planning a golf tournament to be held Oct 6th. It appears we have several golfers in our midst and currently the golf enthusiasts are meeting frequently to get it well off the ground soon.

A family social outing is planned watching our local AA Baseball team, the Chattanooga Lookouts, play at our stadium from a covered picnic pavilion, with full banquet for \$25 per person.

Engaging: We have begun to engage with and have more presence with various other Veteran entities and outreach events.

New website: We have a new board member who also doubles as our webmaster. We hope to have the beginning of our website up and running by the end of this month.

LOE regarding last year: submitted well in advance of the deadline.

Dinner meeting: Plans for our April dinner meeting will honor two JROTC scholarship awardees and a few anticipated academy appointees and family members. A panel of service academy graduates will be available for questions and our own 2VP/Membership Chair will be our guest speaker; Lt. Col. Tony Crowder (Ret) was USAF pilot but also a Federal Senior Executive Service member for Homeland Security, Customs and Border Protection, NATO, CAP, etc. He has had and still has a very distinguished career and will speak to the young people about What is Success (service academy not required).

Parade: We have special plans to appear in our Armed Forces Day parade with a real towed float presence, decorations, followed by luncheon at Chattanooga Convention Center.

Scholarship team/board got together at the home of our President and a very helpful and lively discussion ensued. Our scholarship original documents were found in a notebook which clarified selection processes and legal matters; we need to change our by-laws a bit and we have found a conundrum for which our Treasurer will seek advice from experts at MOAA National. Our scholarship team is actually its own board, and operates separately from our Executive Board.

None of the above would have been possible without the superior keen interest and talent of our 1VP, Ray Mitchell. We have a solid board, but I look forward to what more will be possible when Ray takes the helm.

Finally, we have revamped our membership application to also include a National membership application. Thank you, LTC Karon, Uzzell-Baggett for the assist.

Luncheon Meetings

January 2023 – Chapter members gathered for a review of 2022 accomplishments and reports from various directors. The meeting drew 41 attendees, which is large for this topic. The Chapter's financial status was reviewed and upcoming National and State legislative issues were highlighted. Members approved revised Chapter bylaws and eight new appendices outlining director duties.

February 2023 – The chapter gathered to hear a presentation on the Battle of Nashville

and the contributions of the United States Colored Troops in recognition of African American History Month. There were 47 attendees at Old Natchez Trace Country Club.

March 2023 – Chapter members learned about The Mission Continues, a non-profit focusing on veterans engaged in community-based volunteer projects. The meeting was led by a past Chapter President due to the current President being at a conference.

Advocacy

Members received reminders about advocating for various legislation benefiting the military community at every meeting. The MOAA Legislative Action Center was frequently mentioned.

The Legislative Liaison highlighted important issues pending before the 118th Congress. He stressed encouraging legislators to resubmit the Major Richard Star Act, support restoration of BAH to 100% and reverse cuts to TRICARE pharmacies.

Community Outreach

Members completed the final 2022 MOAA Community Outreach Grant on Saturday, March 4, 2023, at Matthew 25, a local non-profit focusing on rehabilitating formerly homeless veterans. The non-profit received two new computers and printers for the men to use in job pursuits. Chapter members delivered an in-person presentation to 22 men on resume development, interview techniques and other job placement topics.

Three new grant requests for 2023 were researched and submitted to MOAA.

Award – The chapter submitted its second website nomination for the Colonel Marvin J. Harris Communications Award.

Other

The chapter submitted a \$300 request under the MOAA Community Outreach Sponsorship program to purchase a tablecloth and flag emblazoned with the chapter's name. These items will be used during chapter recruiting events.

A community trip to the Tennessee State Museum was scheduled on March 23, 2023, as a follow-up to the February 2023 speaker presentation. Members enjoyed a complete tour of key museum exhibits.

Key leadership vacancies still exist, but dedicated volunteers keep the chapter going forward.

Mountain Empire TN05 – Don Thompson: Written update provided as follows

MECMOAA members sponsored a table at the East Tennessee State University Veterans Day event on 27 March 2023. Ivan Adames, Tennessee Council President participated in the event. TNVETS sponsored a table next to the MOAA table.

Five veterans completed MOAA and MECMOAA membership applications.

ROTC:

MECMOAA members will be presenting awards to cadets at 13 high school JRROTC groups in northeast Tennessee in April and May. MECMOAA has doubled the numbers of awards and scholarships from one to two ROTC scholarships of \$1000 each, and from one to two JRROTC awards of \$500 each. MECMOAA will be awarding the ROTC scholarships at the annual awards ceremony at the next Chapter meeting on 7 May 2023, at 1230.

Membership

We gained 5 new members at the 27 March 2023 Veterans Day event at East Tennessee State University.

Introduction of new VSO, LCDR James R. Dignan, USN (Ret) VSO Dignan provided indepth information on the Burn Pit Registry, Death Benefits, and VA Disability application.

ROTC/JROTC Roundup - Members were given a quick review of activities at each of our sponsored programs by the Liaisons who serve those programs. Liaisons are needed for Cookeville, York, and TTU.

Ft Campbell TN07 – Brian Lynch Verbal-written update provided as follows:

No luncheons were held during either January or February. We did however hold executive committee meetings both months.

Our Chapter has appointed a Scholarship Committee to develop our scholarship program.

The Stones River Chapter of MOAA is also planning a trip to Edelweiss in Germany, Sep 21-October 1, 2023. Approximately 25 members have signed up.

Sumner County TN11- Steve Petersen: Written update provided as follows:

Chapter Board election and installation of officers was conducted in February, 2023.

Input was provided by the three high schools with JROTC Programs in Sumner County for awarding a \$500 scholarship to a deserving senior who will be attending a college or school of higher learning, and the MOAA Medal to a deserving junior. Awards will be provided at each school JROTC awards ceremony by a member of our Chapter in the next couple of weeks. In addition, the MOAA Medal will be awarded to a member of the Springfield High School, TN

AFROTC at their awards ceremony by a member of our MOAA Chapter. Springfield High School is located in Robertson County, TN and the Middle Tennessee MOAA Chapter had previously provided this award. Sumner County is closer and we have followed up on presenting the award to Springfield High School.

Membership We have started a membership drive & reconnection with members who are on our roles but have not been attending. Attendance has been slow to recovery after the pandemic, and our meeting location has changed several times due to forces beyond our control. Currently we have about 50 people that are on our rolls and average 20-25 attending meetings.

Awards & JROTC We are in the process of attending the various JROTC awards programs for the schools we support. We will be awarding our scholarship to the Lebanon High School AFJROTC cadet on 26 April.
